#### ANNEXURE - 'A'

# Scope of Work:

- 1. To perform a thorough survey of existing civil structures through orthographic imaging/LIDAR imaging/manual contouring of the potential sites and submit the CAD/KML files to RIMS authority.
- 2. To perform a thorough survey of existing electrical layout to evacuate the energy generated by the Solar Plant to the respective grid network through NET METERING. Firm/Company should provide SLD for the conductor layout.
- 3. To provide DPR of the solar project to RIMS authority within 7 working days of awarding the tender.
- 4. To provide thorough understanding of applicable model of project.
- 5. To provide spot-on financial estimate of the same Solar Power Plant with as little as 5% deviation.
- 6. To provide a timeline of tendering process and project execution.
- 7. To facilitate Solar Experts having single handed experience, of not less than 500MW of Grid Connected Solar Power Plants for a group discussion with RIMS authority. (Cost of Expert invitation to be borne by the consultancy)
- 8. To provide warehouse for materials required for installation of solar. (Outside RIMS campus)
- 9. To provide temporary workers holding area till the end of execution of project. (Outside of RIMS Campus)
- 10. Project management body should ensure that the plant should be operated at its optimum status throughout its tenure of 25 years.
- 11. To provide regular maintenance services of the project

# **Eligibility:**

- 1. Registered firm having experience in On-Grid solar Power plant or Solar Power Plant consultancy with no less than 5 years of experience.
- 2. The firms/company should have atleast 1.no of PO/WO/SO from central government body with invoice value of Rs. 15 lakhs and above (Single site) and 5 no of State government body with cumulative invoice value of Rs. 25 lakhs and above.
- 3. Firm/Company should have an expert available 24x7 with experience of atleast 100MW solar power plant.
- 4. Firm/Company should have an registered in Imphal or should be willing to set up a registered office/branch office within 3 days from the date of awarding.

- 5. Firm/Company should have necessary surveillance equipment like LIDAR equipped UAV or special purpose mapping devices. Firm/company should also deploy thermal imaging devices to find hot and cold spots on the building roofs to execute heat management with solar modules.
- 6. Project management firm should design/formulate or have an agreement with the project executing company to maintain the plant at its optimum level.
- 7. Project management firm/company will have a bond of minimum of 5 years from the date of tender awarding.

## Penalties:

- 1. RIMS strictly adhere to its timeline so any firm/company not abiding to the timeline will be liable to face monetary penalty of upto Rs.2,00,000/- or termination of contract agreement along with damage.
- 2. Loss of energy due to improper maintenance of plant will be penalized with the amount as calculated per unit loss and will be paid by the project managing firm/company.
- 3. Manufacturing defects detected in the plant should be reported within the first 90 days from the date of project completion otherwise, the management firm/company will be liable to replace the defective component at their company's cost.
