OFFICE MEMORANDUM

Imphal, the 8th August, 2023

Subject: Coverage under Central Civil Services (Pension) Rules, in place of National Pension System of those Central Government employees who were recruited against the posts/vacancies advertised/notified for recruitment, on or before 22.12.2003

No. B/3200/2023-RIMS/4720 The Ministry of Personnel, Public Grievances and Pensions, Department of Pension and Pensioner Welfare vide OM No. 57/05/2021-P&PW(B) dated 03.03.2023 has, inter-alia, decided that in all cases where the Central Government civil employee has been appointed against a post or vacancy which was advertised/notified for recruitment/appointment, prior to the date of notification for National Pension System i.e. 22.12.2003 and is covered under the National Pension System on joining service on or after 01.01.2004, may be given a one-time option to be covered under the CCS(Pension) Rules, 1972 (now 2021).

2. Meanwhile, the Ministry of Health & Family Welfare's letter No. U.12025/22/2023-NE dated 18/07/2023 has conveyed the approval of Secretary, MoHFW in his capacity as Chairman, Executive Council for implementation of the above referred Department of Pension & Pensioner Welfare's O.M. No. 57/05/2021-P&PW(B) dated 03.03.23 in respect of Faculties/Officers/Staff of RIMS, Imphal who fulfill the conditions in aforementioned O.M.

3. All the Faculties/Officers/Staff of RIMS, Imphal who have been appointed against the post vacancies advertised/notified for recruitment/appointment prior to the date of notification for National Pension System i.e. 22.12.2003 are requested to submit their option to consider for coverage under the CCS (Pension) Rules, 1972 (now 2021). The guidelines mentioned in the Dept. of Pension & Pensioner Welfare's O.M. No. 57/05/2021-P&PW(B) dated 03.03.23 will be strictly followed. This option shall be exercised by the concerned Faculties/Officers/Staff latest by **31.08.2023**.
