OFFICE MEMORANDUM

Imphal, the 19<sup>th</sup> February, 2024

No.662/NPS-CRA/2014-RIMS (Pt-II): The National Pension System (NPS) is compulsory for the regular employees, who joined on or after 1<sup>st</sup> January, 2004. The institute has already implemented NPS for those regular employees who joined on or after 01/01/2004 as per letter of consent submitted to Pension Fund regulatory Development Authority (PFRDA), vide letter no. 412/New Pension Scheme-RIMS dated 30/07/2010.

2.45 (Forty Five) Nursing Officers (employees of RIMS, Imphal), have not opened NPS A/C till date as they have filed a writ petition before Hon'ble High Court of Manipur stating that their service should be linked up from the date of initial contract appointment till the date of regularization on 10/01/2011.

3. In the CRA (Central Record Keeping Agency) system of NPS, there is an option for Non NPS withdrawal, whereby, the concerned employees may open NPS A/C until their writ petition case is finalized. They can switch over to Old Pension Scheme under CCS (Pension) Rules, 1972 (now 2021) through this system of Non NPS withdrawal on condition if the outcome of the case is in their favour.

4. Therefore, all the concerned 45 Nursing Officers of RIMS, Imphal are hereby directed to open their NPS A/C without fail within 15 days. The concerned Nursing Officers may contact Shri Rajkumar Ranjit Singh of Pension & GPF Section during office hours for completing the formalities and any assistance in this regard. The list of concerned employees is attached herewith as Annexure.
