Terms and Condition

- 1. The outer cover of the tender should be superscribed "Tender for Printing & Cost of Paper for supply of Hospital Form, Blood Bag Label and Register and inner cover be sealed.
- The tender should reach this office not later than the date, time specified in the tender notice as mentioned above.
 The tender through registered post/courier/hand only will be accepted. Late tender bid submission including
 postal/courier delay will not be considered.
- 3. Samples/Specimen copies of the items to be printed/supplied may be seen from the institute office during the office hours.
- 4. Each tender should be accompied by (1) an earnest money of Rs.50,000/- (Rupees five thousand only) in the form of bank draft from any nationalized /scheduled bank in the favour of Director, Regional Institute of Medical Science, Imphal (2) GST registration Certificate (3) Pan Number (4) Prof of filling of Income tax return for the Assessment year 2022-2023 (5) Registration certificate of the Proprietorship/Firm/Company etc. The Earnest money of successful tender will be converted into security deposite. The Earnest money of the unsuccessful tender will be refunded on demand. (which shall be submitted along with the quotation).
- 5. VALIDITY PERIOD: The rate offered should remain valid for 2 (two) years from the date of acceptance.
- 6. PENALTY: In case supply order is delayed beyond the stipulated time limit in the supply order, a penalty of 10% on the amount of the supply order shall be charged per week of the delay.
