Sir/Madam,

In exercise of the powers conferred by Sections 25(i) and 35(4) of NMC Act, 2019, the approval of PGMEB, NMC is hereby conveyed for grant of **Renewal of Recognition of M.Ch.(Urology) qualification for 02 seats in respect of students being trained at Regional Institute of Medical Sciences, Imphal, Manipur under Manipur University, Imphal, Manipur**, under the following terms and conditions, as contained in the Post Graduate Medical Education Regulations, 2000:

- (i) *The recognition so being granted herein, shall be valid for a maximum period of 05 (five) years from the date of issue, upon which it shall have to be renewed.*
- (ii) *The procedure for 'Renewal of Recognition' shall be same as applicable for the award of recognition.*
- (iii) *Failure to seek timely renewal of recognition as required in sub-clause (i) supra shall invariably result in stoppage of admissions to the concerned Post Graduate Course of the said institute.*


2. The approval for Renewal of Recognition of M.Ch.(Urology) qualification for 02 seats is granted subject to applicability of amendments in NMC Regulations from time to time

3. **As per the Assessor's report -**

- i. There is deficiency of one Associate Professor in the Department of Urology;
- ii. The number of Operation Tables in the Department are to be increased; and
- iii. Separate Operation Theatre and Post-Transplant Isolation ICU is required for renal transplant.

4. You are directed to take corrective steps to rectify the aforesaid deficiencies and inform the Post Graduate Medical Education Board of NMC within six months from the issuance of this letter.
