- 3. The initial engagement would be for a period of 06 (six) months which may be extended further depending on the requirement of RIMS, Imphal and performance review of the faculty or till the posts are created whichever is earlier.
- 4. The candidates have to produce their original certificates & testimonials before the Selection Board.
- 5. Incomplete application and applications received after the stipulated date shall be summarily rejected without any intimation to the candidates.
- 6. The engagement shall be made purely on contractual basis and it will not bestow any rights implicitly or explicitly upon the candidate to claim any permanent absorption or any liability to the RIMS, Imphal on termination of the contract. These posts are purely contractual, and terminable on either side with a notice of one month.
- 7. No Private practice is allowed during the tenure of service at RIMS, Imphal.
- 8. The upper age limit shall be determined as on last date of submission applications i.e. 13.01.2024.
