<u>CIRCULAR</u> <u>Imphal, the 3rd September, 2025</u>

Sub: Supply of Medicines, Consumables and Implants under PMJAY at Approved Package Rates. - Reg.

No.398/CMHT-PMJAY/RIMS-2025: The Director, RIMS, Imphal convened a meeting with all the Heads of Departments implementing the PMJAY Scheme in RIMS, Imphal on 25th August, 2025, in connection with various issues pertaining to the Scheme. In pursuance of the decisions taken, the following guidelines are hereby notified:-

- i. The concerned HODs are directed to prepare and submit a comprehensive list of medicines, implants, consumables, and high-cost items required under PMJAY Scheme, in their respective Department/ units, in comparison with the package rates available in the PMJAY portal.
- ii. Furnish the consolidated information to the Office of the Medical Superintendent by 10th September, 2025 for further necessary action.
- iii. To eliminate out-of-pocket expenditure for beneficiaries, the Institute shall ensure that these items are made available through **AMRIT Pharmacy**.
- iv. In case any required item is not available in AMRIT Pharmacy, the Pharmacy shall issue a **Non-Availability Certificate (NAC)** so that procurement may be made from other empaneled Pharmacies under PMJAY at RIMS, Imphal, strictly at the approved PMJAY rates. In no circumstances, this price will exceed the PMJAY rates.
- iv. Routine consumables such as gloves, syringes, etc. shall be supplied directly by the Institute to the concerned Departments/Units.
- 2. All the concerned HODs/unit head implementing the PMJAY Scheme, shall ensure strict compliance with the above instructions.
- 3. This issues with the approval of Director RIMS, Imphal.
