

**PROCEEDINGS OF THE COMMITTEE MEETING FOR EVALUATION OF TECHNICAL BIDS FOR "PROVIDING PROJECT MANAGEMENT CONSULTANCY (PMC) SERVICES FOR CONSTRUCTION AND DEVELOPMENT OF INFRASTRUCTURE WORKS AT RIMS, IMPHAL." HELD ON 20<sup>TH</sup> OF MARCH, 2024 AT 3:00 P.M. AT THE CONFERENCE ROOM OF THE DIRECTOR'S OFFICE, RIMS, IMPHAL.**

At the outset, the Director, RIMS, Imphal welcomed all the members present and asked the Executive Engineer (Civil) to initiate the proceedings.

The Executive Engineer (Civil) initiated the proceeding by stating that the Institute invited for EOI(s) cum RFP(s) from eligible bidders vide NIT No. EOI-RFP/RIMS/2023-24/1 for the above mentioned subject. The Technical bids were opened as per schedule and 12(twelve) bidders with Eligibility and Technical documents for each were found. For Slab A - 4(four agencies), SLAB B - 2(two) agencies and for both Slab A&B - 6(six) agencies submitted their technical bids. Hard copies of each bid documents were compiled and filed for evaluation purpose on the same day.

At the outset, the Director, RIMS, Imphal welcomed all the members present and asked the Executive Engineer (Civil) to initiate the proceedings.

The Executive Engineer (Civil) initiated the proceeding by highlighting the minutes of the 1<sup>st</sup> Committee Meeting held on 20<sup>th</sup> of march, 2024. He stated that - in the 1<sup>st</sup> meeting, the Committee prepared pre-qualification statements of all the bidders in accordance to the eligibility criteria and technical bids submitted by the bidders. With respect to the pre-qualification statement a general Comparison Statement was drawn which shows the qualification status of all the bidders. The list of bidders/agencies, deemed qualified by the Committee for SLAB A & B in the 1<sup>st</sup> Committee Meeting, may be listed as below:

The Executive Engineer (Civil) also highlighted the recommendation of the 1<sup>st</sup> Committee Meeting in which the members of the Committee also recommended to give the bidders a window period of 7(seven) days from the day of notification for any queries and for representation regarding the qualification status before final shortlisting of qualified bidders for financial bid opening.
