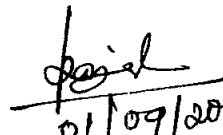

No. ACADEM/ADMN/MDS/1/2026: Applications are invited from intending NEET – MDS 2026 qualified candidates for admission to the postgraduates MDS courses at the Dental College, Regional Institute of Medical Sciences (RIMS), Imphal.

1. Distribution of seats : (Total = 18)
 - (a) All India Quota (AIQ 50%) : 09
 - (b) Institutional Quota (RIMS Dental College Graduate) : 02
 - (c) In service sponsored category : 07
2. Selection of candidates:
 - (a) Selection of candidates will be based on NEET-MDS 2026 score;
 - (b) AIQ will be filled up through all India Counselling;
 - (c) Institutional quota : All NEET MDS 2026 qualified graduate who passed BDS from Dental College, RIMS, Imphal are eligible to apply;
 - (d) In service sponsored category : All NEET-MDS 2026 qualified in-service Dental Surgeons from the beneficiary States of RIMS (Arunachal Pradesh, Manipur, Meghalaya, Mizoram, Nagaland, Sikkim, Tripura) are eligible to apply. In-service candidates of Dental College, RIMS are also eligible to apply under this category. Applications under this category must be forwarded through the competent authority of the respective beneficiary States along with the required documents.
3. Application form and submission:
 - (a) Application forms may be downloaded from the RIMS website: (www.rims.edu.in) and duly filled-in-application forms should be submitted to the Dean (Academics), RIMS or through e-mail: admission.rims.imphal@gmail.com on or before 4:00 p.m. of 14th Sept., 2026.
