The appointment of IEMs under these orders shall be governed by the following terms and conditions: -

To country cerms and conditions:	
Tenure	3 years w.e.f. the date of issue of this order
Fee	Each Independent Monitor shall be paid sitting fee @ Rs.25000/- (Rupees Twenty-five thousands only) per sitting, subject to a ceiling of Rs. 3,00,000/- (Rupees Three lakhs) per annum.
TA/DA	TA/DA in connection with official duties shall be allowed to each Independent Monitor as per normal rates applicable to a serving officer of an equivalent rank.
Transportation	Reimbursement of conveyance charges on the same terms and conditions, as admissible to any serving officer of an equivalent rank under Delegation of Financial Powers Rules.
Secretarial Assistance	Will be provided as and when requisitioned.

- The role and duties of above Independent Monitors will be as per Revised Standard Operating Procedure issued by CVC Circular No. 015/VGL/091 14.06.2023. The threshold limit for procurement for General Administration will be Rs.5Lakhs, while the threshold limit for procurement of other items is Rs.50lakhs.
- 4. Independent Monitors would be required to sign and return a 'Confidentiality Agreement' and 'Declaration of absence of conflict of Interest' (ANNEXURES I & II) within 15 days from the date of issue of this Office order. The Agreement/ Declaration may be initiated on all pages and full signatures affixed on the last page. A copy each of the CVC Guidelines

on "Illustrative check points for various stages of public procurement" and revised SOP vide Circular No.04/06/2023 date 14.06.2023 is enclosed herewith for guidance purpose as ANNEXURES III & IV.
